Conditions:

1. All reproductions must include, at minimum, the Collection name, item number, and the text: "Image courtesy of IAIA Archives, Santa Fe, NM" in a caption or credit. Unless approved in advance by a staff member, each image must be reproduced unaltered and in its entirety
2. Reproductions distributed electronically must contain the credit as part of the image and provide a link to the IAIA website (www.iaia.edu). Reproductions distributed electronically must contain the credit as part of the image. Reproductions distributed electronically shall not exceed a display or print resolution of greater than 170 dots per inch (dpi). The IAIA Archives maintains all property rights over digitally reproduced images taken from original or reproduction images in our collections.
3. Permission for reproduction is limited to the applicant only and is non-transferable. In addition to the permission of IAIA, extra permission may be required. Those permissions may include, but are not limited to:
 - a. Copyright: in cases of living artists and/or subject to the 1976 Copyright Law or the 1991 Visual Artists Rights Act, written permission must be secured by the applicant from the copyright owner and provided to the IAIA Archives. User may be liable for copyright infringement if purposes exceed: "fair use."
 - b. Privacy: the IAIA Archives extends the right to privacy to include ceremonial objects and rites of Native Americans and requires the permission of the tribe's cultural affairs office before releasing reproductions for use.
 - c. Owner of Original: in instances where the IAIA Archives holds only a reproduction, the written permission of the owner of the original may be required for use.
4. Any subsequent change in use from that stated above constitutes reuse and requires new permission from the IAIA Archives.
5. Permission is granted for a single edition. Each separate edition requires new permission.
6. The IAIA Archives reserves the right to refuse reproduction and use of its holdings and to impose such conditions as it may deem advisable to the best interests of IAIA.
7. The applicant agrees to send the IAIA Archives one copy of the work containing the reproduction at no charge.
