Memorandum of Understanding Between Santa Fe University of Art and Design And Institute of American Indain Arts

Santa Fe University of Art and Design ("SFUAD") and Institute of American Indian Arts enter into this Memorandum of Understanding, effective April 7, 2017, for the establishment of a collaboration whereby Institute of American Indian Arts will accept into its institution, currently enrolled and qualified Santa Fe University of Art and Design students for transfer. The entities agree to enter full Transfer Agreements, according to the stipulations and policies below.

Institutions Entering hto Agreement

Santa Fe University of Art and Design

and

Institute of American Indian Arts

Students

Students requiring 36 or more credits to degree completion will be advised to transfer out of the institution. However, IAIA may offer to waive its residency requirement and therefore accept teach-out-eligible students. SFUAD will be responsible for identifying students eligible for teach-out versus transfer according to this guideline, and will cooperate with IAIA to identify and provide relevant program information regarding transfer-eligible students, in accordance with FERPA regulations.

Timing

Curriculum mapping and the establishment of course equivalencies will be completed and executed via a Transfer Agreement no later than April 14, 2017.

IAIA will be expected to participate during the Weeks of April 17 – 21, 2017 and April 24 – 27, 2017 in advisement sessions and transfer events hosted by SFUAD. The SFUAD Teamwillwork with IAIA to develop and market events, distribute information to SFUAD students, and work through other planning logistics during this period.

Transfer Criteria

- Suitability and similarity of programs with good faith that maximum transferability of coursework will be realized in accordance with AIA established transfer policies. This assumes that IAIA has reviewed SFUAD's course credit structure and in good faith enters into this agreement on this premise.
- The majority of SFUAD transfer-eligible students meet admissions requirements.
- SFUAD students will receive comparable or lower total out-ofpocket costs.
- SFUAD students will be treated fair and equitably in the transfer process.
- IAIAprovides equivalent student support services.

Accreditation

SFUAD and IAIA are accredited through the Higher Learning Commission (HLC). IAIA is currently in good standing with HLC and other accreditors.

Transfer Student Policies

We will allow SFUAD students admission without the regular requirements. Listed below are the requirements for admission into IAIA.

Admission:

If the student has more than 24 transferable credits, we will require \$25.00 Application Fee; Admissions Application and all official college transcripts.

If the student has less than 24 transferable credits, we will require the above and the student's high school transcript indicating graduation date.

Orientation will be required for all transfer students on: August 11, 2017 and we will offer a "Welcome" date TBD in the Summer.

AIA

- Will accept into its applicable programs qualified students who are currently enrolled at SFUAD, according to the transfer policies and process articulated in this agreement.
- Will coordinate with SFUAD transfer team staff to participate in on campus transfer events.
- Will provide permission for SFUAD to publicly announce through its website, press releases, or other communications channels the transfer agreement with IAIA

SFUAD:

 Will cooperate with IAIA to provide information and support during the curriculum mapping and course equivalency process inorder to establish maximum transferability of coursework.

- to provide information to Will cooperate with IAIA students regarding program offerings and transfer incentives, as articulated in this agreement.
- a list of transfer eligible students to Will provide IAIA include credits completed, cumulative GPA, program information, contact attempts, and other relevant information.
