Dr. Martin, President, called the President's Cabinet Meeting to order at 11:02 am MST.

During the Board meeting, each new Trustee discussed their impressions of their first meeting. They were impressed with the level of IAIA staff professionalism. Dr. Martin commended the Cabinet and staff for their diligent efforts.

Charles Galbraith and Lawerence Roberts are both in the Washinton, D.C area and are willing to approach Congress and advocate on behalf IAIA.

Dinner at the Shed honored Barbara Blum and Sonya Kelliher-Combs with a Pendleton blanket for their service to IAIA.

Dr Martin added Higher Learning Commission (HLC) Board Meeting actions to the agenda. Actions included the following:

- Review of the accreditation criteria will begin in the fall, which is required every five years.
- Approved on first reading a Fraud and Abuse Policy.
- Approved a revised policy for teach out for students when an institution or institutional program is closing. This is the first reading and proposed change will go to membership for comment.
- First reading for clarifying that an institution may be placed on Notice when it is the
 collective judgment that it is in danger of being out of compliance for the assumed
 practices, accreditation criteria or federal compliance requirements.
- Policy regarding change of control or structure requests. Before the HLC can consider a change of control or structure reques, the pre-acquisition letter from Department of Education must be received. Also discussed was was r lawsuits filed by institutions

against HL. If the lawsuit is unsuccessful, legal costs will be incurred by institution filing legal action.

Darren Benjamin, Senior Staff, House Appropriations Committee, U.S. House of Representatives and accompanied by Jackie Kilroy and Kristin Richmond, two subcomittee staff, visited the campus on February 24. The groupd visited the museum, toured the campus and met with students. Mr. Benjamin was obtismistic regarding FY 17 funding.

5. Johnson Scholarship Foundation Site Visit- Dr. Martin

Visit to review IAIA;s management of the Johnson Scholarship Foundation funds will be Friday, March 10, 2017. The Johnson Foundation provides IAIA Business and Entrepreneurship Program students approximately \$30,000 a semester. Johnson Scholarship consultants stated that at some point in the future that our funding may become an endowed scholarship. IAIA students will be included in the site visit. Steve Fadden will be representing the Academic Division in Dean Teters absence. Dr. Martin also requested that Laurie Logan Brayshaw attend the meeting. Former American Indian College Fund (AICF) president, Richard Williams, and Sherry Salway Black will be representing the Johnson Scholarship Foundation.

6. Achieving the Dream Iniative - Bill Sayre, Nena Anaya, Carmen Henan

Achieving the Dream is a non-governmental reform movement made up of community colleges and TCUs dedicated to increasing student success. IAIA is a partial member, through AIHEC support, but hope to become full members through additional support from AICF. IAIA's involvement would mean an institution-wide focus on student success through collaboration of all divisions/departments on campus.
