Dr. Martin, President, called the President's Cabinet Meeting to order at 11:02 am MST.

Opening

Laurie Logan Brayshaw, Director of Sponsored Programs, gave the Opening for the meeting.

2. Opening Positive Note(s)

Dr. Robert Martin, IAIA President, announced Judith Peppers was offered and accepted the position of the new director of the Office of Institutional Advancement and will start June 2017.

3. Approve Cabinet Meeting Minutes

Dr. Bill Sayre, Director of Institutional Research, moved to approve the meeting minutes; Charlene Carr, Land Grants Program Director, seconded the motion. Larry Mirabal, Chief Financial Officer and Gracie Schild, Advancement Service Manager (guest) abstained; There was no further discussion. Dr. Martin called for a vote; all in favor – 8; opposed – 0; abstained – 2

The President's Cabinet approved the March 1, 2017, meeting minutes.

4. AIHEC Presidents Meeting- Dr. Martin

Beginning in mid-2010, AIHEC convened TCU presidents collectively and in a small working group to discuss the possibility of developing a tribally-controlled accrediting body specifically for American Indian higher education. The presidents of these institutions determined as one of AIHEC's goals to be the creation of an accreditation body that would be recognized by federal, tribal, and state governments and which would articulate accreditation standards or a framework for the development of such standards uniquely relevant to Tribal Colleges and Universities. During the recent AIHEC TCU presidents meeting there was a motion, and a resolution passed that each nine TCUs voluntarily paid \$36,000 and move toward \$110,00.00 needed to begin the accreditation process. Dr. Martin will recommend that all colleges be assessed an accreditation fee.

AIHEC Student Activites discussed the upcoming 2nd Annual World Indigenous Nations (WIN) Games which will be held July 1 – 9, 2017, Edmonton, Alberta, Canada. The University of Alberta and the City of Edmonton are partnering to bring the Games to Edmonton, Canada. The opening ceremonies will occur on July 2nd and will close on July 9th at the Enoch Powwow. Indigenous Peoples from Canada will showcase Indian Horse Relay, Lacrosse and

Denesuline Hand Games. Participating countries will also share their traditional games as a demonstration sport throughout the week.

AIHEC Student L.I.F.E. Conference, hosted by ASC, will be held June 6-9, 2017 at Haskell Indian Nations University, Lawerence, Kansas.

AIHEC 2018 Spring Student Conference will be held March 11-14, 2018, Bismarck, North Dakota.

AIHEC Spring 2019 Basketball tournament will be held at Little Big Horn College, Crow Agency, Montana.

AIHEC Spring 2020 Spring Conference will be held in Albuquerque, New Mexico. Dr. Martinwill submit a proposal to host the basketball tournament at the newly constructed gymnasium on the campus of the Institute of American Indian Arts, Santa Fe, New Mexico.

H.R,.292 sponsored by Congressman, Don Young, Alaska, Honoring Our Trust Relationship Act of 2017 or HOT-R Act-This bill amends the Balanced Budget and Emergency Deficit Control Act of 1985 to exempt specified American Indian and Alaska Native programs from sequestration, including programs administered by the Departments of the Interior, Education, Housing and Urban Development, Justice, and Health and Human Services (Sequestration is a process of automatic, usually across-the-board spending reductions under which budgetary resources are permanently cancelled to enforce specific budget policy goals.)- AIHEC has proposed a change in language to specifically include tribal colleges/universities.

5. AIHEC Student Conference- Carmen Henan

The AIHEC Student Conference was held at the March 19-21, 2017 in Rapid City, South Dakota, hosted by the Oglala Lakota College.

13 IAIA students attended the AIHEC Student conference in which IAIA won 28 awards. Two IAIA students, ASC SW Representative- Scarlett Cortez and ASC Historian – Leroy Grafe; were elected to the AIHEC Associated Student Congress

Leroy Grafe took eight awards on behalf of IAIA and also elected to AIHEC Student Congress. He was considered IAIA MVP by his fellow students.
